EXHIBITION BOOTH AT THE HF 25 NORDIC HF CONFERENCE

XXX (henceforth named the Exhibitor) has been assigned an exhibition booth at the HF 25 conference by the Organisers. The exhibitors are expected to share the costs for the Exhibition Party planned for Monday evening of the conference (the cost estimate is SEK 4000-8000 per exhibitor – lower for small organisations; higher for the large ones, to be paid to the camp office in cash or by credit card). Apart from this there will be no extra charges attached to your use of the exhibition booth.

The exhibition (and also the coffee/tea place) will be in the same building as the lecture hall. Outdoor exhibit space is available adjacent to the lecture hall. Wire antennas may use the nearby trees as support.

Registration

The exhibition grounds are accessible from 10 August, 09.00 (local time) to 13 August, 16.00. The conference is scheduled for 11 - 13 August 2025.

- the outside area surrounding the exhibition grounds can be used if needed.
